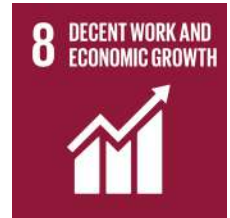

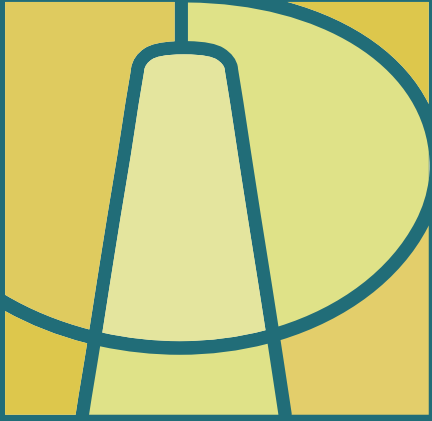


THE B CORP DECLARATION OF INTERDEPENDENCE
